Annual increase of 3% for Councilors Bode, DeValois, Kuiken, Lenssen through December 31, 2025 [NOTE: 2017 not addressed specifically in the ordinance for councilmembers]

Beginning January 1, 2018: All Councilmembers set at monthly rate of \$636.54, then annual 3% increases through December 31, 2025
